REQUIRED DOCUMENTS FOR HOUSING APPLICATION

- 1. Official Birth Certificate for each member of your household.
- 2. Social Security Card (or Alien registration).
- 3. Proof of Income for each member of your household (TANF, Child Support, Social Security, Retirement, Interest, etc.).
- 4. Proof of U.S. Citizenship or Non-Resident Status (Voters Registration, Green Card, INS Verification, etc.).
- 5. All household members 18-years or older <u>MUST</u> accompany you to complete additional paperwork.

REQUIRED INFORMATION:

- 1. <u>MUST</u> provide names, addresses, and telephone numbers to verify where you lived for the last 5 years.
- 2. <u>MUST</u> provide amount of monthly living expenses.
- 3. <u>MUST</u> be able to secure utilities in name of Head of Household.

ADDITIONAL DOCUMENTS:

- 1. Food Stamp verification listing all individuals in the household receiving assistance.
- 2. Proof of Student Status if attending any technical school or college either part time or full time and proof of any grants/scholarships or student loan amounts.

OTHER FACTS REGARDING APPLICATION APPROVAL:

- 1. A criminal background check will be done on any applicant 18 years of age or older.
- 2. All applicants will be screened by the Lifetime Sex Offender Registry.
- **3.** Any applicant that has previously lived in Assisted Housing and owes Money will be required to satisfy that debt before being housed.
